

GIVING TO LIFE REDUCES YOUR TAX BURDEN!

THE STATE OF KANSAS HAS RENEWED THE PREGNANCY RESOURCE ACT FOR 2026.
THIS BILL PROVIDES A KANSAS INCOME TAX CREDIT OF 70 PERCENT ON ELIGIBLE DONATIONS.

HOW IT WORKS:

- 1 Complete Form K96. Find it on our website at <https://lifeandhopeteam.org/tax-credit/>
We will accept K96 forms for donations of \$100 or greater.
- 2 Send the completed Form K96 to Becky Dixon at bdixon@wpcnetwork.org or mail it to:

- 3 We will pull the supporting documentation for your donation and approve Form K96.
- 4 We will submit Form K96 to the Kansas Department of Revenue on your behalf.
- 5 Upon approval by the Kansas Department of Revenue, we will email your approval certificate to the email address you provided on Form K96. **Please confirm receipt of this email when you receive it.**
- 6 When you receive it from us, provide the approval certificate to your tax preparer.

IMPORTANT INFORMATION TO ALSO KNOW:

- 1 Make checks payable to "**Wyandotte Pregnancy Clinic, Inc.**" While we operate the Wyandotte and Olathe locations and the mobile unit, the Kansas Department of Revenue will only accept checks written to our legally registered name. If you would like your donation designated to Olathe's operations, you may include Olathe in the memo line of the check.
- 2 Donations from Donor-Advised Funds or Foundations are not eligible for this tax credit.
- 3 **Form K96 must be submitted within 30 days of the donation date. Please deliver the form to us at least one week prior to allow time to process by the due date.**
- 4 Form K96 must be completed for each donation you make throughout the year. If you make monthly donations, you may submit Form K96 on a quarterly basis for the total of three months' donations.
- 5 Form K96 must be completed in full and include valid email and phone number. Be sure to sign and date the form under "Certification by Donor."
- 6 For year-end donations, Form K96 must be submitted to us by January 20 to allow time to get the information submitted to the Kansas Department of Revenue by their deadline.
- 7 If a check is received from a company, they will be considered the donor. If the company is a pass-through entity, a list of shareholders/partners and their percentage share must be uploaded.
- 8 The State of Kansas has approved \$10 million in tax credits for the year 2026. Once this limit is reached, no further credits will be approved. WPC cannot guarantee that your K96 application will be approved.
- 9 For questions regarding your specific tax situation, please discuss with your tax advisor.
